CTTF Activities

- Regular meetings with SJC Staff and FDOT to discuss road improvement progress and community outreach and communications.
- In Q1 2023, the CTTF's community survey received 2000 responses from the 9000 households reached regarding community roadway issues.
- Over 80% of respondents supported A1A intersection improvements.
- The CTTF regularly publishes a newsletter to keep the community informed about roadway conditions and progress towards improvements that is widely circulated in our area.

A1A Intersection Progress

- The A1A improvements were recommended by a 2017 Traffic Study funded by SJC and the NFTPO.
- Since 2018 the CTTF has requested and each year our Legislative Delegation has generously provided incremental funding advancing the A1A intersection improvements.
- Progress to-date with Legislative Delegation Funding:
 - ✓ A1A and Solana Road turn lane extension, 2020
 - ✓ A1A and Mickler Road intersection improvement to be completed Q1 of 2025
 - ✓ A1A Intersections PD&E On-Going

DUE DILIGENCE COMPLETE:

- ✓ A1A in Ponte Vedra Beach is SJC's #4 Transportation Priority
- ✓ FDOT funded PD&E for A1A Corridor
- ✓ FDOT funded A1A Resurfacing Design in 2025/26
- ✓ FDOT supports combining Resurfacing and Intersection Design in 2025/26
- ✓ FDOT supports combining Resurfacing and Intersection Construction

CTTF 2025 Request

\$6 Million for SR-A1A Intersections in Ponte Vedra Beach for Design, ROW, and Construction

- ✓ Aligning Design and Construction of A1A Intersections with the FDOT Resurfacing makes \$20M of improvements cost \$12M
- ✓ Start of Resurfacing and Intersection Construction as soon late 2027
- ✓ FDOT and SJC support
- ✓ Community support
